#### Product description

The affected product is a full body safety harness. The harness has yellow and black 4.5 centimetre (1 <sup>3</sup>/<sub>4</sub> inch) webbing with pass through mating connector buckles at the leg and chest straps. There is a black and white laminated product label with 3M brand mark and manufacturer information.

## Hazard identified

Internal testing by 3M has indicated that the product did not meet the independent harness strength test as required in the Canadian Standards Association standard, which may pose a fall hazard to the user.

Neither Health Canada nor 3M has received any reports of incidents or injuries to Canadians related to the use of this safety harness.

## Number sold

An unknown number of the safety harnesses were sold into Canada.

## Time period sold

The recalled safety harnesses were sold from May 2012 to July 2013.

In an effort to ensure that 3M provides our customers with high quality products and services, we have recently completed an analysis of Model Number 10910 SafeLight Full Body Harness (3M Material Number 70071532652) (UPC 78371000790). We have identified a limited number of these units manufactured from May to August, 2012 that may not meet the independent harness strength test when tested as defined by CSA Z259.10 requirements.

As a result, 3M has chosen to voluntarily recall the products which may have been impacted by this issue and requests that you immediately identify and remove from service all affected model 10910 SafeLight harnesses within your inventory. Affected products will be identified on the product label by W/O Number **30502770, 30510681, 30511698 or 30519806**.
